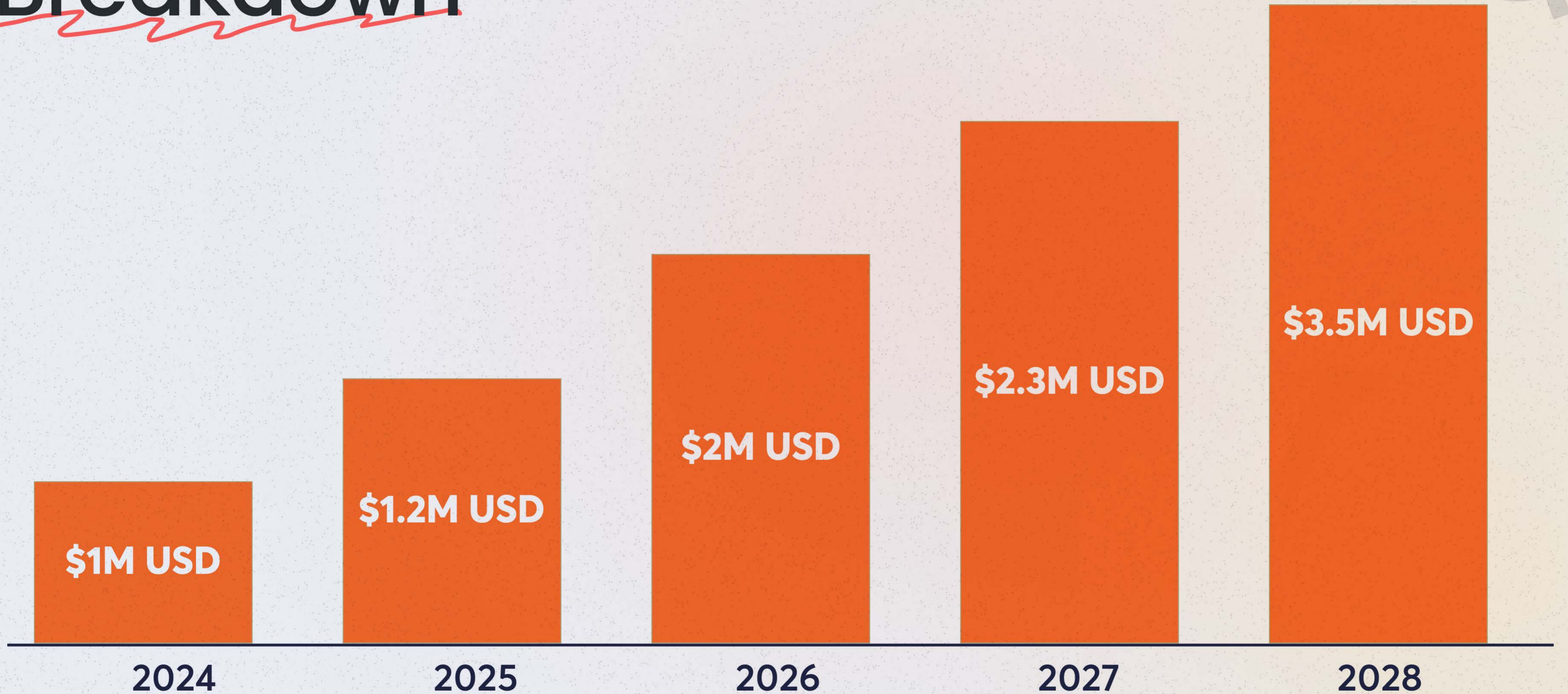


Valuation By 2028

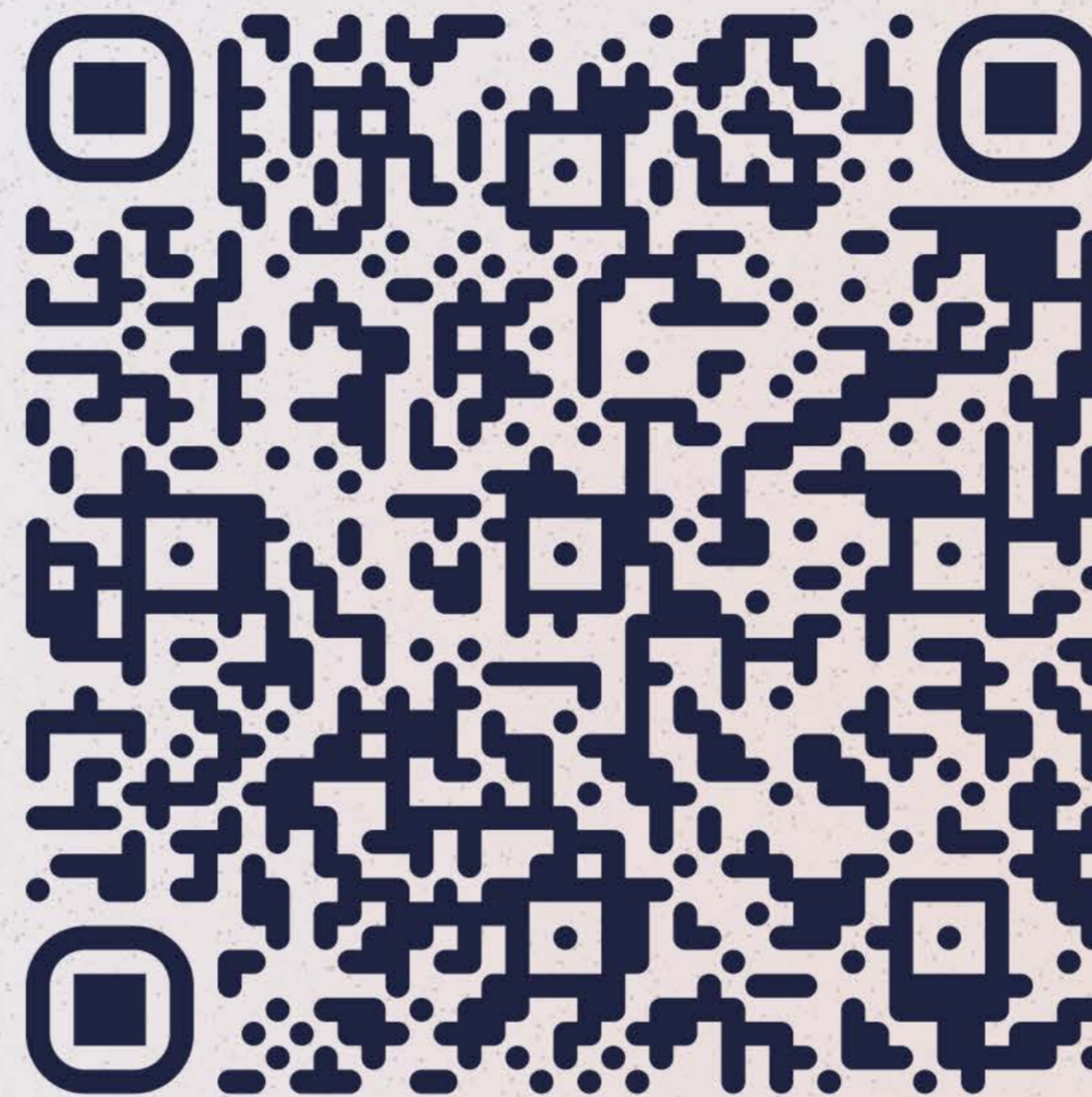
